BONDING AGENT INFORMATION

It is the policy of the Warren County Sheriff's Department to accept a bond from any current bonding agent within the State of Missouri. Prior to accepting a bond, our corrections personnel will verify the agent's bonding status by requiring proof of identity such as a valid Missouri driver's license or identification card, and a copy of the bond license issued by the State of Missouri. Such credentials will be checked against a statewide list of authorized bonding agents. This list is maintained by the State of Missouri, and is updated on a monthly basis.

For security and logistical reasons it is not practical to provide the jail population telephone books from throughout the region. For convenience we post a list of Bail Bond Agents that have a local Warrenton 456, 377, or 297 telephone number. If you are a licensed bonding agent, with such a local number, and you would like to be included on this list, please contact me at the above office number. Agents will be displayed on this list in alphabetical order using the name registered with the State of Missouri.
