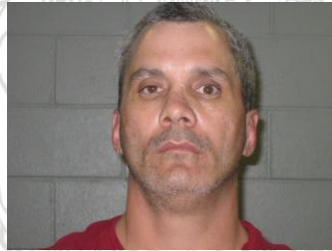

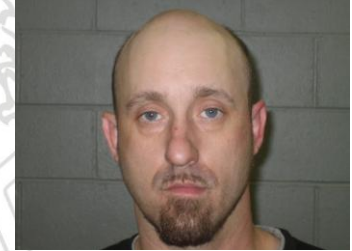
Warren County Sheriff Kevin Harrison reports the arrest of six suspects and the discovery of a clandestine methamphetamine laboratory being operated in a residence located at 712 Steinhagen Road in Warrenton Missouri. The arrests and lab discovery were the result of a search warrant that was executed around 1:00am on the morning of May 7, 2010 by members of the Warren County Sheriff's Department, the Warrenton Police Department, and the East Central Drug Task Force. The search warrant was the result of an ongoing investigation into the possession, sale, and manufacturing of controlled substances at the location. The suspects were identified as:

Inside the residence the detectives located and seized the ingredients and components of a clandestine methamphetamine laboratory, multiple bindles of methamphetamine, loaded syringes of methamphetamine, and other items of drug paraphernalia. A three year old child was also located inside the residence that was taken into protective custody and released to the Department of Social Services Children's Division.
